As a participant of the activities and/or by entering the Attraction, I accept those risks which a prudent person is or should be aware and understand the requirement to always exercise good judgement and act in a responsible manner whilst undertaking the activities at the Attraction.

By signing this form, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that I and all participants may be exposed to or infected by COVID-19 by attending the Attraction.

I agree to explain and ensure any participant for whom I am responsible and who is listed in this form is aware of the requirements for attending and participating at the Attraction. Waiver of Rights and Release from Liability
